

MONTHLY WATER RATE SCHEDULES **BUTLER COUNTY WATER SYSTEM, INC.**

A. GENERAL SERVICE RATES ¹

(Effective 11-1-25)

5/8 X 3/4 INCH METER

First	2,000 Gallons	\$26.92 Minimum Bill*
Next	4,000 Gallons	7.81 per 1,000 Gallons
Next	44,000 Gallons	6.93 per 1,000 Gallons
Next	50,000 Gallons	5.97 per 1,000 Gallons
Over	100,000 Gallons	4.97 per 1,000 Gallons

*The \$26.92 Minimum Bill applies to 5/8 x 3/4 inch meters only. The Minimum Bills below will apply to all other meter sizes.

1"	\$ 51.17 Minimum Bill, includes first	5,000 Gallons
1-1/2"	91.43 Minimum Bill, includes first	10,000 Gallons
2"	134.21 Minimum Bill, includes first	16,000 Gallons
3"	217.86 Minimum Bill, includes first	25,000 Gallons
4"	301.40 Minimum Bill, includes first	30,000 Gallons
6"	526.44 Minimum Bill, includes first	60,000 Gallons
8"	667.73 Minimum Bill, includes first	80,000 Gallons

The rates to be charged after the minimum rate are the same regardless of meter size. All rates are subject to 10 percent penalty if paid after the due date.

B. SEPARATE PRIVATE FIRE SERVICE RATES ²

¹ It is permissible and the Water System recommends one service connection be used for both the normal water use and fire service. The general service rates would apply for all water usage.

² Private Fire Service charges shall apply to all connections which provide service only for private fire protection facilities whether supplied through a fully metered service or an unmetered service with a detector check valve and bypass meter. Customer charges are lump sum charges according to the applicable service size with zero water usage. In case of a fire, charges for water usage shall be in accordance with Butler County Water System, Inc. Tariff Section II. F. Fire Protection. Charges for all other water usage shall be in accordance with prevailing Butler County Water, System, Inc. rates for general service. Where a detector check valve with a bypass meter is used, the water usage shall be based on the combined volume of water used through both the detector check valve (estimated) and the bypass meter. All rates are subject to 10 percent penalty if paid after due date.

TAP-ON FEES

(Effective 11-1-24)

1. 5/8 x 3/4 inch meter \$1,711.00

If a road crossing is required for the Water System's service line to reach a proposed meter location and the distance from main to meter is 60 feet or less, the cost of the road crossing is included in the above price. If the total service line length is greater than 60 feet, the customer shall pay the cost of installing the additional footage.

2. Larger meters Actual Cost of Installation

The contribution for all water service installations larger than 5/8 x 3/4 inch shall be the actual cost of the complete water service installation including the cost of crossing the road and any equipment required to meet the customer's water supply needs. An estimate of the cost shall be made by the Water System and paid in advance by the customer prior to the installation. Any over-payment shall be refunded by the Water System and any under-payment shall be paid by the customer to the Water System.
